

2024 USA PICKLEBALL PARTNER SWEEPSTAKES

The 2024 USA Pickleball Partner Sweepstakes (“Promotion”) begins on November 13, 2024, at 7:00:01 a.m. local Arizona time and ends on November 17, 2024, at 07:00:01 p.m. local Arizona time (the “Promotion Period”). Sponsor’s website is the official time keeping device for the Promotion.

1. **Sponsor.** This Promotion is sponsored by USA Pickleball Association (“**Sponsor**”). The Promotion is not sponsored, administered or otherwise endorsed by any social media platform, including without limitation X, Meta, TikTok, Facebook or Instagram.
2. **Eligibility.** The Promotion is open to legal residents currently residing in the 50 United States and the District of Columbia who are at least twenty-one (21) years old, as of the date of his/her Promotion entry (“Entrant”). Entry constitutes Entrant’s full and unconditional agreement to these Official Rules and to Sponsor’s decisions, which are final and binding in all matters related to the Promotion and which Sponsor may decide in its sole discretion. **OFFICIAL RULES ARE SUBJECT TO CHANGE WITHOUT NOTICE.** Winning a prize is contingent upon fulfilling all requirements set forth herein. For purposes of this Promotion, each Entry pursuant to the above directions constitutes one (1) entry. Limit: one (1) entry per person. No automated entry devices, bots and/or other programs and/or software are permitted for entry. No mechanically reproduced or incomplete entries will be accepted.

Selection Date. One (1) winner from each day of the Promotion Period, with the exception of November 13, 2024, which will be two (2), will be selected no later than 11:59 p.m., November 20, 2024, local Arizona time.

It is an Entrant's responsibility to monitor its email address. If Sponsor is unable to contact an Entrant or Entrant has not responded within forty-eight (48) hours from when the notification was sent, is not in compliance with these Official Rules or declines to participate (or accept a prize) for any reason prior to award, its status in the Promotion (or as a recipient of any prize) will be forfeited and, in Sponsor's sole discretion, an alternate Entrant may be selected.

All Entries become the property of Sponsor and will not be acknowledged. Any attempt to obtain Entries in excess of the limit on Entries as set forth in these Official Rules, including by using creating multiple social media accounts, identities, forms, registrations, or by any other methods, will void all of the relevant Entrant's Entries, and that Entrant will be disqualified at Sponsor's sole discretion. All valid, eligible Entries submitted in accordance with these Official Rules shall be hereinafter referred to as "Eligible Entries."

Potential winner will have forty-eight (48) hours to respond before the prize is forfeited and an alternate winner is selected. 7. General Conditions. Except where prohibited, Entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of Arizona or the appropriate State Court located in Maricopa County, Arizona; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion not to exceed fifty US Dollars (US\$50.00), but in no event attorneys' fees; and (3) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
